The notice requirements of Section 121.22 of the Revised Code and the implementing rules adopted by the Board pursuant thereto, were complied with for the meeting.

Mr. Ingold moved the adoption of the following resolution:

RESOLUTION NO. 2021-070

A RESOLUTION DETERMINING TO PROCEED WITH THE SUBMISSION TO THE ELECTORS OF NORWAYNE LOCAL SCHOOL DISTRICT THE QUESTION OF THE RENEWAL OF AN EXISTING TAX LEVY, PURSUANT TO SECTIONS 5705.194 THROUGH 5705.197 OF THE REVISED CODE.

WHEREAS, on May 25, 2021, this Board adopted a resolution declaring it necessary to submit to the electors of the District the question of the renewal of an existing tax levy in excess of the ten-mill limitation, as described below, a copy of which resolution was certified to the Wayne County Auditor; and

WHEREAS, that County Auditor subsequently certified to this Board that the total current tax (assessed) valuation of the District is \$205,685,500 and that the estimated annual tax levy required throughout the life of the proposed levy to produce the annual amount of \$280,000 as set forth in that resolution, calculated in the manner provided by Section 5705.195 of the Revised Code, is 1.45 mills for each one dollar of valuation, which amounts to 14.5 cents for each one hundred dollars of valuation;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Norwayne Local School District, Counties of Wayne and Medina, State of Ohio, that:

- Section 1. This Board hereby determines to proceed with the submission to the electors at an election to be held on November 2, 2021, of the question of the renewal of all of an existing tax levy in excess of the ten-mill limitation (commencing with a levy on the tax list and duplicate for the year 2022 to be first distributed to the Board in calendar year 2023) in order to raise the amount of \$280,000 each year for 10 years for the purpose of providing for the emergency requirements of the School District, at the annual tax rate as is necessary to raise that amount, which rate is currently estimated by the Wayne County Auditor to be 1.45 mills for each one dollar of valuation, which amounts to 14.5 cents for each one hundred dollars of valuation.
- Section 2. The Treasurer is authorized and directed to certify to the Wayne County Board of Elections copies of this resolution and the resolution of this Board and certificate of the County Auditor referred to in the preambles hereto, before 4:00 p.m. or the earlier close of business on August 4, 2021. This Board hereby requests that the Board of Elections give notice, prepare the ballots, and make other necessary arrangements for the submission of this question to the electors of this District, all in accordance with law.

- Section 3. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this resolution were taken, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were held, in meetings open to the public in compliance with the law.
- Section 4. This resolution shall be in full force and effect from and immediately upon its adoption.

Notice is hereby given that in pursuance of resolutions of the Board of Education of the Norwayne Local School District, adopted on May 25, 2021 and June 28, 2021, there will be submitted to a vote of the electors of said School District at an election to be held in said School District at the regular places of voting therein, on Tuesday, November 2, 2021, the question of the renewal of all of an existing tax levy in the sum of \$280,000 per year for a period of ten years for the purpose of providing for the emergency requirements of the School District. If a majority of the voters voting thereon vote in favor thereof, that tax will commence in 2022 and be first due in calendar year 2023.

The estimated tax outside of the ten-mill limitation necessary to raise that annual amount as certified by the County Auditor is 1.45 mills for each one dollar of valuation, which amounts to 14.5 cents for each one hundred dollars of valuation.

The polls for said election will be open at 6:30 a.m., and will remain open until 7:30 p.m., of said day.
