The Board approved the Resolution to place a 2 Mil Permanent Improvement Levy Renewal on the November 5, 2019 Ballot in Wayne and Medina Counties:

The Board of Education of Norwayne Local School District, Ohio, met in regular session on July 22, 2019, called to order at 4:00 p.m., in the Norwayne High School Library, 350 South Main Street, Creston, Ohio, with the following members present:

The notice requirements of Section 121.22 of the Revised Code and the implementing rules adopted by the Board pursuant thereto were complied with for the meeting.

Mr. Steiner moved the adoption of the following Resolution:

RESOLUTION NO. 2019-51

A RESOLUTION PURSUANT TO SECTION 5705.21 OF THE REVISED CODE SUBMITTING TO THE ELECTORS OF THE NORWAYNE LOCAL SCHOOL DISTRICT THE QUESTION OF THE RENEWAL OF AN EXISTING TAX LEVY FOR THE PURPOSE OF "RENOVATION AND REPAIR OF SCHOOL BUILDINGS, IMPROVEMENT OF SCHOOL SITES, PURCHASE OF NEW EQUIPMENT AND REPLACEMENT OF OBSOLETE EQUIPMENT".

WHEREAS, at an election held on May 5, 2015, the electors of this School District approved the renewal of a 2.0-mill levy for the purpose of "renovation and repair of school buildings, improvement of school sites, purchase of new equipment and replacement of obsolete equipment", for five years; and

WHEREAS, the authority to levy that 2.0-mill tax expires with the levy on the 2019 tax list and duplicate for last collection in calendar year 2020, and, in order to provide for the collection of tax revenues for that purpose without interruption, this Board finds it necessary to renew the existing 2.0-mill levy for five years; and

WHEREAS, on June 24, 2019, this Board adopted a resolution pursuant to Section 5705.03(B) of the Revised Code, declaring it necessary to renew the existing 2.0-mill tax levy and requesting the Wayne County Auditor to certify the total current tax valuation of the School District and the dollar amount of (annual) revenue that would be generated by that renewal levy; and

WHEREAS, the County Auditor thereafter certified that the total tax valuation of the School District is \$179,290,090 and the estimated property tax revenue that will be produced by the 2.0-mill renewal tax levy is \$106,500 annually during the life of the levy, assuming that the tax valuation remains constant throughout the life of the levy;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Norwayne Local School District, Counties of Wayne and Medina, State of Ohio, *two-thirds* of all members concurring, that:

Section 1. This Board hereby finds, determines and declares that the amount of taxes which may be raised by the Board of Education of the Norwayne Local School District within the ten-mill limitation by levies on the current tax list and duplicate will be insufficient to provide an adequate amount for the necessary requirements of this School District, and that it is necessary to levy a tax in excess of that limitation at the rate of 2.0 mills for five years for the purpose of "renovation and repair of school buildings, improvement of school sites, purchase of new equipment and replacement of obsolete equipment", being a renewal of all of an existing tax levy.

Section 2. The question of the renewal of an existing 2.0-mill tax levy for the purpose of "renovation and repair of school buildings, improvement of school sites, purchase of new equipment and replacement of obsolete equipment", for five years, beginning with the tax list and duplicate for the year 2020, the proceeds of which levy first would be available to the School District in calendar year 2021, shall be submitted under the provisions of Sections 5705.21 and 5705.25 of the Revised Code to the electors of the Norwayne Local School District at an election to be held therein on November 5, 2019, as authorized by law. That election shall be held at the regular places of voting in the School District as established by the Wayne County Board of Elections, or otherwise, within the times provided by law and shall be conducted, canvassed and certified in the manner provided by law.

Section 3. The Treasurer of this Board is hereby authorized and directed to give or cause to be given notice of that election as provided by law.

Section 4. The Treasurer is hereby directed to deliver a certified copy of this resolution, together with the resolution adopted on June 24, 2019, referred to in the third preamble to this resolution, and the related County Auditor's certificate, to the Wayne County Board of Elections, Ohio, not later than the close of business on August 7, 2019.

Section 5. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this resolution were taken, and all deliberations of this Board and of any of its committees that resulted in such formal action were held, in meetings open to the public, in compliance with the law.

Section 6. This resolution shall be in full force and effect from and immediately upon its adoption.

NOTICE OF ELECTION ON TAX LEVY IN EXCESS OF THE TEN-MILL LIMITATION

Notice is hereby given that in pursuance of resolutions of the Board of Education of the Norwayne Local School District, Wayne and Medina Counties, Ohio, adopted on June 24, 2019 and July 22, 2019, there will be submitted to the electors of the Norwayne Local School District at an election to be held in that School District at the regular places of voting therein, on Tuesday, November 5, 2019, the question of levying a tax in excess of the ten-mill limitation for the benefit of the School District for the purpose of renovation and repair of school buildings, improvement of school sites, purchase of new equipment and replacement of obsolete equipment, at a rate not exceeding 2.0 mills for each one dollar of valuation, which amounts to 20 cents for each one hundred dollars of valuation, for five years. Said tax constitutes the renewal of all of an existing 2.0-mill levy. If a majority of the voters voting thereon vote in favor thereof, that levy will be first placed on the tax list and duplicate in December 2020 for first collection in calendar year 2021.

The polls for the election will be open at 6:30 o'clock, a.m., and will remain open until 7:30 o'clock, p.m., of said day.
