Wayne County Community Federal Credit Union will award two Scholarships in 2025. The scholarships (in the amount of \$1,000 each) are awarded to credit union members graduating high school in 2025 and will be pursuing degrees beginning in the fall of 2025. The application deadline is March 31, 2025. A committee appointed by the credit union board of directors will screen applications and select the recipients. Scholarships will be granted based on the information supplied on the application, as well as the additional materials requested. The recipients will be notified in April 2025 and awards will be presented to winners at WCCFCU's annual meeting in May 2025. Attendance and acceptance of the award at the annual meeting is preferred, but not required to win. Funds for each scholarship will be paid to the graduate directly. Scholarship awards may be taxable, please consult a tax professional.
